Bureau of Early Intervention 217.782.1981 The Early Intervention Training Program is slating five Regional Conferences between November and June. A registration form is on page 5-6 of this newsletter. Conference dates are:

The regional conferences have been extended to two full days. The additional afternoon sessions on day two will be more interactive and have a focus on problem solving.

Another new feature is that the EI Training Program is inviting Early Intervention parents to attend the confer-

ences so they can benefit from the information and resources that are shared.

"Our first Regional Conference in Mt. Vernon was very successful, yet we also received many comments from participants who wanted two full days of workshops," explained Ted Burke, El Training Program director.

"Our training team decided that the additional sessions on day two should be interactive, with videos and case studies, as well as offer participants the opportunity to come with questions and then let the group brainstorm suggestions."

Each regional conference will offer a selection of threehour sessions in the morning and afternoon on day one, followed by one-hour question/answer sessions on Credentialing and Billing/Insurance. There will also be at least one full-day

session on day one, including the required Evaluation/Assessment training. Day Two of the conference includes a selection of threehour sessions in the morning and two-hour sessions after lunch. The day two problem-solving sessions will focus on topics such as Service Coordination: From Intake to Outcomes: The IFSP Team Meeting: Effective Practice and Problem Solving and How Families can Make El Work For Them.

The attendance fee for each Regional Conference is \$25, which includes continental breakfast and lunch on both days. Parents whose children are receiving El services can apply to the EIPALS program for a stipend to pay the registration cost.

Program Director's Notes By Ted Burke

Welcome to the first newsletter of FY04 This past year proved to be a successful one. We hope to build on this success in the upcoming year to better meet the needs of providers in the field. Here are just a few of our accomplishments from last year

- Provided 172 workshops statewide which were attended by 5,255 participants.
- Developed the EI Training website, <u>www.illinoiseitraining.org</u>, which averages 60,000 requests per month
- Co-sponsored and/or provided El credentialing hours for 568 additional training events held by other entities (e.g. Universities, STAR NET, Illinois Medical Diagnostic Network, Head Start, Hearing and Vision Connections, individual Child & Family Connection office, Local Interagency Councils, Ounce of Prevention, Hospitals and State Provider Associations)
- Issued 237 certificates to individuals for activities meeting continuing professional education standards for early intervention

Focus for the Future

The El Training Program is looking at ways to bring additional trainings to areas of the state in the upcoming fiscal year. The Regional Conference in Mt. Vernon during the summer was very successful. We are scheduling five additional conferences through June of 2004. Participants who attend a conference can earn up to 12 hours of ongoing professional development credit.

Our training also program hopes to provide more opportunities in the upcoming year. An El Training Advisory Group was organized and has identified a number of pediatric based training opportunities that can be offered statewide. Our agenda for this fiscal year also includes the following goals:

- Continue to produce training videos for dissemination via the web
- Examine alternate methods to deliver trainings to the growing number of El providers such as videophone and web based training
- Distribute training needs assessment statewide
- Collaborate with new and current partners to provide accessible training opportunities for all providers and parents in the El system.



Is assistive technology really important for young children?

Many of the skills learned in life begin in infancy: AT can help infants and toddlers with disabilities learn many of these crucial skills. In fact, with assistive technology, they can usually learn the same things that nondisabled children learn at the same age, only in a different way. Communication skills at this age are especially important because most of what an infant or toddler learns is through interacting with other people, especially family members and other primary caregivers.

Sometimes parents are reluctant to begin using an AT device because they believe it will discourage their child from learning important skills. However, the opposite may be true. Research has shown that using AT devices, especially augmentative communication devices may actually encourage a child to increase communication efforts and skills. It is important to remember that the earlier a child is taught to use an AT device, the more easily a child will accept and use it.

Assistive technology is also important because expectations for a child increase as those around them learn to say, "This is what the baby can do, with supports," instead of, "This is what the baby can't do." With assistive technology, parents learn that the dreams they had for their child don't necessarily end when he or she is diagnosed with a disability.

This library is designed as an exchange network in which medical equipment can be obtained or donated.

Working your way through the seven menu options listed on the left of the home page, you'll find access to our most current training calendar of events as well as to other El resources. At the top of the menu selection is the training calendar. A click here takes you to eight categorical options developed to make it easier for you to find what you are looking for.

With the exception of the 'View All Events' category, the categories are pretty self-explanatory and will take you to everything we have currently scheduled in that particular category. 'View All Events' brings up all training events scheduled in the current month. You will need to scroll through the successive months, listed under the header on the page, and select a month to view all training events scheduled in a particular month.

A new addition to the menu options is "Trainings Requested and Approved for El Credit.' This feature brings you to categorical options as in the 'El Training Calendar' selection. Here you'll find an alphabetical listing of training workshops and courses that have been submitted to us and approved for El credit.

'The 'Links' option at the bottom of the list offers links to DHS-Illinois Bureau of Early Intervention where current El Rule and Policy is posted in full. Provider Connections can also be accessed through this option with all of the appropriate credentialing forms and paperwork available to download for your use.

Tools approved for El assessments are posted on the 'Assessment Tools' link and 'Answers to Your Credentialing Questions' connects you to an easy-to-read table of early intervention credentialing requirements that reflect the changes made in Rule 500 earlier this year.

We hope that these changes allow more of you to become frequent users of our website. Easier access to our training events and an immediate time-response to your online registration give frequent website users the advantage to the latest Illinois Early Intervention events and resources.

What is "Informed Clinical Opinion"

Informed Clinical Opinion means:

♦ An opinion made by practitioners qualified to evaluate the child's five developmental domains.

♦ An opinion that is based on multiple sources of qualitative and quantitative information about the child's development.

♦ An opinion that also is based on conversations among parents, service coordinators and the multi-disciplinary team members who were a part of the evaluation process accompanied by a written explanation that documents a disability or delay.

What are some tips for putting the IFSP in Motion?

- ◆ View implementation as the beginning of the process, rather than the end.
- ◆The planning piece is critical the better the planning, the fewer problems with implementation.
- ♦ Be sure that everyone knows who will do what, when, where and how.

Make a list of what has to happen right away to set the wheels in motion and be sure that all steps are addressed.

- ♦ Make sure that everything on the IFSP gets put in place.
- ◆ Check back with the family early and often in the beginning to make sure that things are happening as planned.
